Mr. Dillon stated that we are here to open sealed bids for the Wastewater Facility Expansion and Upgrade. We have requested sealed bids to be provided at this time on this date. Any bids received after this time will not be considered responsive. The bids are not subject to public disclosure until the District provides notice of a decision or intended decision or until ten days after bid opening, whichever comes first.

The engineer's estimate was passed out to the attendees. Mr. Dillon stated that he will be looking for six things in the bids; the bid form completed and signed, security, acknowledgment of addendums, Appendix G & H signed, Bidder Qualifications, and that the FL Trench Safety form is filled out and signed. The bids will be open in the order that they appear on the bid work sheet. Syndi Trakul explained that the order of the companies on the work sheet reflect the order in which the plans were turned in.

Mr. Dillon announced that the apparent lowest bidder was Meadors Construction Company Inc. Please see attached Bid Tabulation sheet for all bids received.

Mr. Dillon announced that the District will be moving into their responsibility review after the number have been doubled checked and making sure that what appears to be the case is actually the case.

He also stated that the District reserves the right to reject all bids and unless the District rejects all bids, its intent is to award the work to the lowest qualified responsible and responsive bidder.
