

RESOLUTION 04-03-05

A RESOLUTION OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT, REPEALING SECTION 48-101.003 OF THE DISTRICT'S INTERIM WASTEWATER POLICIES

WHEREAS, by Resolution 2003-9, dated February 5, 2003, the District adopted interim wastewater policies consisting of the wastewater and reclaimed water rules and regulations of the Florida Keys Aqueduct Authority as they existed at the time of District adoption; and

WHEREAS, the interim wastewater policies incorporated a provision at Section 48-101.003, providing that the District follows the Uniform Rules of Procedure published in Chapter 28, of the Florida Administrative Code; and

WHEREAS, the Uniform Rules of Procedure were adopted by the State of Florida in order to implement the Florida Administrative Procedures Act (Fla. Stat. ch 120); and

WHEREAS, the District is not subject to the Florida Administrative Procedures Act; and

WHEREAS, the District Board of Commissioners intends to adopt permanent wastewater policies in the near future, and has concluded that the subject interim policy will hinder the process of adoption of permanent wastewater policies;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT THAT:

1. Section 48-101.003 of the interim wastewater policies is hereby repealed.
