RESOLUTION 18-10-07

**A RESOLUTION OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT, AMENDING THE DISTRICT GENERAL RULES AND REGULATIONS TO PROVIDE FOR A CHARGE TO BE IMPOSED ON PERSONS WHO FAIL TO CONNECT TO THE DISTRICT WASTEWATER SYSTEM AFTER PROPER NOTICE, AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Key Largo Wastewater Treatment District (“District”) is in the process of completing a wastewater management system consisting of a treatment plant, transmission line, and collection systems serving the properties located on the Island of Key Largo; and

**WHEREAS**, the District desires to provide for instances where persons fail to connect to the wastewater system after received proper notice to connect;

**NOW, THEREFORE**, the Key Largo Wastewater Treatment District hereby amends the District General Rules and Regulations by adding a new Section 9.08, as follows:

**Section 9.08 Failure to Connect after Proper Notice.**

The District will charge a non-connection charge to be added to all other District monthly wastewater charges, to be imposed upon any customer who, after proper notice, fails to connect to the District wastewater system. The term “proper notice” shall mean that the District has mailed, by certified mail, return receipt requested, a one-year notice and a 30-day notice to the customer at the address shown in the records of the Monroe County Property Appraiser or the Florida Keys Aqueduct Authority. The amount of the monthly charge shall be \$\_\_\_\_.

This resolution shall become effective upon adoption by the District Board.
