

RESOLUTION NO. 01-01-13
A RESOLUTION OF THE BOARD OF COMMISSIONERS
APPROVING THE REQUEST OF SAM CAPLAN FOR
REMOVAL OF TWO TAX PARCELS FROM THE 2008
PRELIMINARY NON-AD VALOREM ASSESSMENT; AND
PROVIDING FOR APPLICABILITY AND AN EFFECTIVE
DATE.

WHEREAS, the Key Largo Wastewater Treatment District approved the request of the property owner, Sam Caplan to waive service to the parcels described in Section 2; and

WHEREAS, the Key Largo Wastewater Treatment District has determined the parcels described in Section 2 are adjacent to the parcel described in Section 1 which is receiving service, and that the three parcels are developed and used as a single property;
