

RESOLUTION NO. 23-07-13

A RESOLUTION OF THE BOARD OF COMMISSIONERS APPROVING THE REQUEST OF RENE CASTILLO FOR REMOVAL OF ONE TAX PARCEL FROM THE 2008 PRELIMINARY NON-AD VALOREM ASSESSMENT; AND PROVIDING FOR APPLICABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Key Largo Wastewater Treatment District approved the request of the property owner, Rene Castillo to waive service to the parcel described in Section 2; and
