

RESOLUTION NO. 24-08-14

A RESOLUTION OF THE BOARD OF COMMISSIONERS APPROVING THE REQUEST OF THE UNITED STATES OF AMERICA FOR REMOVAL OF TWO TAX PARCELS AS CONSERVATION FROM THE 2006 PRELIMINARY NON-AD VALOREM ASSESSMENT; AND PROVIDING FOR APPLICABILITY AND AN EFFECTIVE DATE.

WHEREAS, The Tax Parcel described in Section 1 is being conveyed to the Everglades National Park, a Federal agency, for the purpose of protecting the natural environment, preserving wildlife habitat under the provisions of Chapter 380, F.S. and/or Monroe County Code section 2-397; and

WHEREAS, the owner(s) of the parcel described in Section 1 has made an application for exemption and has certified that if they later desire wastewater service to the contiguous tax parcel, they agree to pay the full direct and indirect District costs of providing the same; and

WHEREAS, pursuant to the Key Largo Wastewater Treatment District General Rules and Regulations Section 10.06(a)(iii), the Owner(s) may request the District exclude the Tax Parcel and waive all future Assessments of the SDC, for that Tax Parcel.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT THAT:

The lot designated in Section 1 below be and is excluded from the Preliminary Key Largo Wastewater Treatment District 2006 Non Ad-Valorem Assessment.
