**A RESOLUTION OF THE BOARD OF COMMISSIONERS
APPROVING THE REQUEST OF LAZY LAGOON LLC
FOR REMOVAL OF ONE TAX PARCEL FROM THE 2008
NON-AD VALOREM ASSESSMENT; AND PROVIDING
