

RESOLUTION NO. 05-07-18

A RESOLUTION OF THE BOARD OF COMMISSIONERS APPROVING THE REQUEST OF KEITH DURHAM AND MONICA MENZEL FOR THE REINSTATEMENT OF ASSESSMENT OF ONE TAX PARCEL TO THE 2018 NON-AD VALOREM ASSESSMENT; AND PROVIDING FOR APPLICABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Key Largo Wastewater Treatment District (“District”) assessed the parcel listed below in Section 1 (“Excluded Tax Parcel”) via Resolution 11-08-07 dated August 21, 2007, the Final Assessment Resolution for 2007; and

WHEREAS, in accordance with Section 10.6(a)(i) of the General Rules and Regulations, the parcel owner(s) waived their right to receive wastewater service and requested that the District suspend collection of the System Development Charge (“SDC”) and all future non-ad valorem Assessments on the Excluded Tax Parcel; and

WHEREAS, in accordance with Section 10.6(b) of the General Rules and Regulations, the Excluded Tax Parcel owner(s) certified and agreed that if they later desire wastewater service to the parcel, they would pay the full direct and indirect District costs of providing the same; and

WHEREAS, the District subsequently issued a waiver of the SDC and all future District initiated non-ad valorem Assessments on the Excluded Tax Parcel listed in Section 1 below, which was recorded in the Office of the Clerk of the Circuit Court of Monroe County, in Official Records Book 2299, at Page 1111 on the 5th day of June, 2007; and

WHEREAS, the current owners of the Excluded Tax Parcel, Keith Durham and Monica Menzel have requested a reversal of the waiver of wastewater service, and agreed to pay the SDC all future non-ad valorem Assessments, and the full direct and indirect District costs of providing service to the Excluded Tax Parcel; and

WHEREAS, the District hereby approves the request of the current parcel owners, Keith Durham and Monica Menzel to reverse the waiver.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT THAT:

Section 1.

Section 2. Resolution number 11-08-07 dated August 21, 2007 (The 2007 Final Assessment Resolution), Exhibit 3.01 (Assessment Roll) is hereby amended to include the Parcel listed in Section 1 above Excluded Tax Parcel.

Section 3. The owners shall pay the SDC in the amount of \$ 6,125.00, plus additional costs of \$0.00, plus an administrative fee of \$ 200.00 for a total of \$ 6,325.00. This amount is due and payable in full on the effective date of this Resolution.

Section 4. APPLICABILITY AND EFFECTIVE DATE. This resolution shall take effect upon adoption by the Board of Commissioners.

Section 5. AUTHORIZATION OF DISTRICT OFFICIALS. The General Manager and/or his designee(s) are authorized to take all actions necessary to implement the terms and conditions of this resolution.



KEY LARGO WASTEWATER TREATMENT DISTRICT




